

Terms & Conditions

GENERAL CONDITIONS

All orders for goods shall be subject to these terms and conditions. No variation of these terms and conditions shall apply unless agreed in writing by Guru Singh Khalsa.

Guru Singh Khalsa guarantees that all goods on offer are as described on the website and are fit for their intended purpose. Should any product fail to meet our high standards it will be replaced immediately. This does not affect your statutory rights.

PAYMENT

Payment for goods ordered can be made by any major credit card or debit card through PayPal.

In the event of payment being declined by your card issuer, Guru Singh Khalsa shall not be responsible for any costs or inconvenience caused by a subsequent delay in dispatch.

DELIVERY METHODS - UK MAINLAND

In general orders are dispatched 3-7 working days after they are received. Please therefore allow 10 days for delivery.

Delivery charges to UK mainland addresses will be charged as indicated in the basket at check out.

DELIVERY CHARGES AND METHODS - OVERSEAS

Orders to overseas locations are subject to delivery charges depending on destination. Please note that because of their higher value and an increase in parcels going missing in transit, all overseas orders will be sent using a tracked delivery system. CANCELLATION OF ORDER
